

## Granting conditions Tim Meijerink Fonds

### A. Conditions of the application

For a project to be eligible for funding by the Tim Meijerink Fonds, the following conditions have to be met:

- Both the project for which the funding is requested and the (main) organiser(s) need to be non-profit of nature.
- The Tim Meijerink Fonds does not grant structural subsidies.
- The project for which the funding is requested needs to be a concrete activity that promotes and improves the visibility, acceptance and/or self-esteem of people within the LGBTQIA+ community. It must be clear from the application how the project tries to achieve these goals.
- It must be clearly described for whom the activity is being organized, and how the organization will try to reach these people.
- The Tim Meijerink Fonds can distribute around €10.000,- annually. Since we would like to support as many initiatives as possible, we ask applicants to take this into account when gauging how much money should be requested.
- The project has to take place within twelve months of granting the subsidy. This requirement can be waived after consultation with the committee.

Beside these basic conditions, we especially welcome events and projects that met one or more of the following conditions:

- projects that are supported and run by volunteers (since *Stichting PANN* is a purely volunteer-based organization)
- projects that especially cater towards marginalized groups (in the broadest sense) within the LGBTQIA+ community
- projects that try to connect different (sub)groups within the LGBTQIA+ community; and
- projects that take place or are aimed at places where there is relatively little positive attention for LGBTQIA+ topics.

Finally, there are a few special conditions:

- A maximum of 10% of the funds from the Tim Meijerink Fund are allocated to projects that take place (primarily) outside the Netherlands.
- We do not support graduation projects.
- In principle, we do not support applications for participating with a boat at Dutch Pride parades. An exception may be made if the organization is participating for the first time and has limited financial resources available.

Examples of projects for which subsidies were granted in the past:

- A dinner at which refugees were connected to LGBTQIA+ youth.
- A photo exposition on (queer) body positivity in the gym.
- The development of a picture book about transgender feelings for children in elementary school

### B. The application

The subsidy applicant must submit the application via our application form. This form can be found at [pann.nl/tm-fonds](https://pann.nl/tm-fonds). It is also possible to attach files to this form.

The application needs to contain at least:

- A description of the project and why it meets the conditions specified above;
- A budget estimate containing the intended contribution of the Tim Meijerink Fonds and (if applicable) other funds or grants.

## C. Deadlines

The applications will be discussed by a committee within *Stichting PANN*. The committee meets four times a year, hence, applicants should take some waiting time (max. 3 months) into consideration when applying. ## D. Results

The committee will correspond about their decision concerning the application via email. It is not possible to appeal against this decision. Even if we can not support your project financially (at this point in time), the Tim Meijerink Fonds is open to collaborate in other ways, for example by providing educational materials or by sharing our experience in organizing large events.

## E. Accountability

- The applicant must make mention of the name and the logo of the Tim Meijerink Fonds when communicating and promoting the project, in particular on the website (if there is one), on banners, or in program booklets distributed at the event. Our logo can be downloaded from [pann.nl/tm-fonds](http://pann.nl/tm-fonds).
- In consultation with the applicant, we will decide if and how the project will be promoted via the communication channels of *Stichting PANN* - that is, on social media, the website and/or during *PANN* events. This could be both before or after the event has taken place. Further information about this will be sent after the subsidy has been granted.
- In principle, funds are granted after the event has taken place. In consultation with the committee, we can decide whether a (partial) down payment might be possible.
- Within a month of the event, the committee would like to receive a subsidy accounting, consisting of:
  - A final financial statement of the project and the corresponding receipts, invoices, etc.
  - A short report with quotes from participants/visitors and photo/video material of the activity.
